BYLAW NO. 2023-02

A BYLAW TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSABLE PROPERTY WITHIN THE SUMMER VILLAGE OF PARKLAND BEACH IN THE PROVINCE OF ALBERTA FOR THE 2023 TAXATION YEAR

Whereas, the Council of the Summer Village of Parkland Beach has prepared and adopted detailed estimates of the Summer Village's revenues and expenditures as required, at the Council meeting held on April 17, 2023; and

Whereas, the estimated municipal revenues and transfers from all sources other than taxation is estimated at \$142,287.50 and the balance of \$331,246.41 is to be raised by general municipal property taxati`on; and

Whereas, the estimated municipal expenditures (excluding non-cash items) and transfers set out in the budget for The Summer Village of Parkland Beach for 2023 total \$457,533.91; and

Whereas, the requisitions are:

Whereas, the Council of The Summer Village of Parkland Beach is required each year to levy on the assessed value of all property, tax rates sufficient to meet the estimated expenditures and the requisitions; and

NOW THEREFORE under the rules and authority of the Municipal Government Act, the Council of The Summer Village of Parkland Beach, in the Province of Alberta, enacts as follows:

1. That the Chief Administrative Officer is hereby authorized to levy the following rates of taxation on the assessed value of all property as shown on the assessment roll of The Summer Village of Parkland Beach:
